Vernona Substation

The Verona Substation was built in 1997. It provides power to the Virgelle, Colony Bay, Big Sandy and Hopp-Illiad areas which powers approximately 687 meters. This substation is fed with a 161kV transmission line operated by Western Area Power Administration (WAPA).



Hill County Electric Faced a 30-Hour Outage

In April, Hill County Electric experienced a significant 30-hour outage in the Verona Substation that highlighted both the challenges of energy distribution and the remarkable resilience of the community it serves. The cause? A 161kV bushing failure on the transformer, which is critical to power delivery.



Understanding Bushings: The Unsung Heroes of Transformers

For those unfamiliar with the intricacies of electrical transformers, bushings play a crucial role. These components, insulators, allow electricity to enter or exit a transformer—essentially acting as the gateway for high-voltage lines. When a bushing fails, it can result in hazardous conditions, necessitating immediate action to prevent further damage or prolonged service outages.

Upon discovering the bushing failure, Hill County Electric crews worked to determine the severity of the damage, temporarily made repairs, and replaced the damaged bushing. WAPA had to bring in equipment to test the transformer before HCE was able to re-energize the transformer. This was a temporary fix and HCE needed to coordinate a specialized team to come in and permanently repair and test the transformer.



Further Testing

Immediately following the April outage, HCE employees worked on a plan to keep power on during the four-day outage for the repair that was required on the temporary fix for the Verona Substation transformer. HCE explored two options to keep power on for Members. The first was to power the Distribution Substations using a public utility company in Montana. The second was through a series of generators. HCE was forced to go with option 2.

During the four days of intense work, Hill County Electric ran four substations off diesel generators, which were brought in to help maintain service. This solution allowed the team to keep essential services running while addressing the transformer repair.

The cooperation from community members played a critical role during this outage. Hill County Electric expressed heartfelt gratitude to its members who reduced their electric loads during the outage. This collective effort made a significant difference, ensuring that power remained on in homes despite the substation being down.

The community's commitment extended beyond just load reduction. Numerous members came forward to assist during the substation outage, demonstrating the spirit of teamwork and cooperation that defines Hill County Electric Cooperative.



The Logistics of Generators

Over the course of the four-day repair operation, Hill County Electric utilized approximately 13,000 gallons of diesel to fuel the generators that kept the substations operational. Over 1,000 feet of cable was deployed to wire the generators. Substations are not designed to work off diesel generators. This logistical effort was no small feat and required meticulous planning and execution from the Hill County Electric team and contractors ensuring minimal disruption to services throughout the region.







Kudos

Kudos must go to the dedicated team at Hill County Electric, whose expertise and quick thinking were vital in engineering and implementing the generator setups. Their ability to adapt to unforeseen challenges is a testament to their commitment to providing reliable electricity to their members. For HCE employees, the 4-day outage took weeks of planning and preparation.

Hill County Electric extends its gratitude to all members and employees for their cooperation and commitment during this outage.
